APPLICATION INSTRUCTIONS

APPLICATION

ALWAYS TEST A SMALL INCONSPICUOUS AREA PRIOR TO FULL APPLICATION. Use the product neat. Mask up any adjacent surfaces to prevent damage. Protect plants and grass etc. from overspray/run off. Brush or

spray on the cleaner, working well into stain and leave for 15 - 20 minutes. After this time, use a hard bristle brush to remove the stain. Finally, wash down the area with water, preferably with a hose, before the product dries. Take care not to allow residues to run directly into fresh watercourses.

CAUTION – COLOURED PAVING AND BLOCKS. This product is extremely aggressive and can discolor cer-

LIMITATIONS

- On very sensitive surfaces, a 1:2 (cleaner to water) dilution as a trial is recommended.
- Always wash the surface down after treatment.
